Motion by Langworthy, seconded by Allen to return to open session at 7:28 p.m. No notes or minutes were taken during the executive session. Motion by Allen, seconded by Langworth to approve the employment of everyone listed on attachment A and attachment B for the FY 2023-2024. Motion carried 4-0.

Motion by Barron, seconded by Langworthy to deem all technology items listed as having no value. Motion carried 4-0.
