Motion by Barron, seconded by Allen to approve the minutes from the last regular board meeting. Motion carried 4-0.

Motio by Barron, seconded by Allen to approve General Fund warrants 249-395 and purchase orders 211-217 and Building Fund warrants 13-17. Motion carried 4-0.

Motion by Cole, seconded by Allen to approve the Oklahoma Union Remediation Report. Motion carried 4-0.

Motion by Barron, seconded by Cole to approve the Procurement Plan and Protest Procedures for Oklahoma Union School Child Nutrition Programs. Motion carried 4-0.

Motion by Barron, seconded by Allen to approve the school carnival, poinsettias sales, and Read-A-Thon as fundraisers. Motion carried 4-0.
