

OKLAHOMA UNION PUBLIC SCHOOL REGULAR BOARD MEETING MINUTES

May 8, 2024, 7:00 P.M.

Board President, Mark Huntington called the meeting to order at 7:00 p.m. Members present were Witney Allen, Joanne Langworthy, Mark Huntington, and Hannah Nolte. KY Cole was absent. Others present were Brenda Taylor - Superintendent, Lisa Harris - Minutes Clerk, along with 10 patrons, see attached sign in sheet.

Motion by Allen, seconded by Langworthy to amend the minutes from the April 10, 2024 regular meeting adding to the HEARING FROM THE PUBLIC: John Lewis asked if the janitorial staff had certain people that were over them and Mrs. Taylor replied it was her. Motion carried 4-0.

Motion by Langworthy, seconded by Allen to approve purchase order# 270-273, General Fund encumbrances # 1498-1647 in the amount of \$560,788.31 and Building Fund encumbrances # 59-66 in the amount of \$256,466.62. Motion carried 4-0.
