Motion by Allen, seconded by Cole to hire Alana Murphy as the elementary school principal on a certified administrative contract for the 2026-2027 school year.

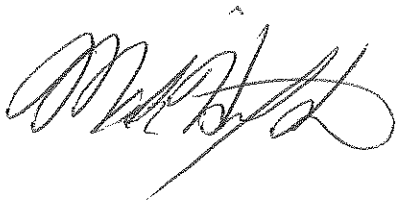
